Dear Community Corrections Co-workers:

The Hennepin County Commissioners have chosen the MCCA to represent social service agencies on the newly formed Corrections Advisory Board. MCCA now has one of its members on the Anoka, Hennepin and Ramsey Corrections Advisory Boards.

The International Halfway House Association Region V Conference sponsored by MCCA was considered by all as a worthwhile experience. Over one hundred people from eight states shared ideas on community-based programs.

The MCCA sponsored three workshops at the recent MCA Conference. Our topics were: Treatment of the Sex Offender, Specialized Problems of the Female Offender, and Corrections Problems in the Rural Community. We tried to address issues that are often avoided by most conferences.

MCCA MEETS ON COMMUNITY CORRECTIONS ACT

The MCCA general membership meeting was held October 26 and the topic was how the Community Corrections Act affects community based programs. Panel members were: Tom Foster, Anoka Court Services; Pat McManus and Bev Tallman, Department of Corrections; Dick Scherman, Hennepin County Court Services; John O'Sullivan, Hennepin County Criminal Justice Coordinating Council and Bob Hanson, Ramsey County Court Services.

Sixteen programs were represented at the meeting and questions flowed freely from the audience. The cooperation and communication was evident and the Act is a real boon for community based programs. It is up to us to lobby and provide quality service to the Act counties.

GROUP INSURANCE

LEGISLATIVE CONCERNS

The Legislative Committee of the MCCA met on November 9th to discuss any legislation which might affect community corrections and which is being considered for the next legislative session.

It appears that the Determinate Sentencing bill may not come out of committee and therefore it may be a dead issue this session.

Representative Thomas Stoa is working on a bill in which work release would be extended to include education and treatment.

The Department of Corrections has prepared draft copies of some bills they may propose during the up-coming session.

One bill proposes that a \$10.00 fee be charged to each felon when they are convicted. This money is to be used to compensate victims of crime.

LEGISLATIVE CONCERNS - cont'd.

Another proposed bill would provide community service orders as an alternative to prison sentences. It would make it possible for community work to take the place of a sentence, up to 300 hours in a twelve month period provided:

1. the person consents;
2. the work is available;
3. a P.S.I. is done.

Another proposed bill would make some changes in Minnesota Statutes 1976, Section 241.021, Subdivision 1. This present law requires the Commissioner of Corrections to inspect all Correctional Facilities. The proposed revision would require the Commissioner to license and inspect correctional facilities.

It also defines what a correctional facility is, and provides for the revocation of the license of those correctional facilities (except jails and lockups) which do not conform to minimum standards.

In this proposed admendment "correctional facility" is defined to mean any facility having a residential component and in which fifty-one percent of the persons served by the facility in any calender year were placed therein by a court, court services department, parole authority, or other correctional agency having dispositional power over persons charged with, convicted, or adjudicated to be guilty or delinquent.

 MEMBER last month's anonymous letter? The following are responses we received.

"To The Anonymous Letter Writer:

Personally, I think your letter smacks of professional snobery and has the flavor of someone who feels powerless. I also believe that someone with your attitude would tend to be ineffectual in their job.

When we receive a resident into Portland House with your set of problems, we try to teach him that life, indeed, is unmanageable (everyones). That a power greater than ourselves is managing for all of us and that human beings, as well as systems, aren't perfect. (Alas, there are a few disgruntleds at P.H.) I am grateful for the knowledge and comfort received when something in my life, like a system, is unmanageable. I can turn it over to a higher power to manage (In my case, God).

What might help you to work comfortably and effectively in an imperfect system with imperfect people is to learn: (1st) The serenity prayer; God grant me the serenity to accept the things I cannot change, the courage to change the things I can and the wisdom to know the difference, (2nd) to become aware of your arrogance, feelings of powerlessness and the need to control, (3rd) do what you can everyday to make an impact that will help to improve the system. This is all any of us can really do.

A second response:

"In response to your anonymous but cynical reader I would like to point out the Self Concept Improvement Program as one designed for the client, which is working on no grant money and who will take all referrals on the basis that we feel confident in our program design.

Our total budget is under \$40,000 and includes the salary, expenses, equipment and supplies for two full time and one part time staff.

The staff personnel, in addition to prior training requirements, must be associated with the SCIP program a minimum of 9 months before being allowed to facilitate our workshop. During this time they are required to take outside training in Gestalt techniques as well as 70 hours of in-house training.

We serve clients of the state Department of Corrections, Hennepin County Court Services, and other agencies both public and private, and have designed programming for Genesis II, Freeport West, WHO, Tri House and others, based on the needs of their clientele.

Is our program successful? I don't know. We have yet to come up with a satisfactory device to measure our success. However, in the two and a half years of our existence, our recidivism ratio is about 3% and using the Tennessee Self Concept Scale as a pre and post testing device we have had only one client who has not shown marked improvement in the overall areas being tested.

We are proud of our record and we delight in being open, honest and direct in stating who we are and what we stand for.
